Affidavit of Financial Support

To be used by students who are financially dependent on the support of others.

If you need a new Form I-20, UMES is required by the U.S. government regulations to determine whether you have adequate funding for tuition, fees, and living expenses for the duration of your stay. The International Students Team will be unable to process your request for a new Form I-20 until funding documentation is complete.

Documentation of Funds

Complete this form and provide accurate, correct, and honest documentation as required. All documentation of the sources of support that you submit must:

- Include the sponsor's name
- Be dated within the last 6 months; and
- Be written in English

Affidavit of Support

A <u>separate</u> affidavit is required for <u>each sponsor</u>. The affidavit <u>should not</u> be less than the minimum requirement of the estimated expenses of \$33,500.

Bank Statement

Each personal sponsor (friends or family) must provide a bank statement or letter from the bank showing U.S. Dollars or the type of currency where the account is held. It must total the amount needed. The sponsor on the Affidavit of Financial Support and the account holder on the official bank statement must be the same.

Estimated Expenses
