## 1890s Extension

Greater funding needed for historically black universities providing educational services and extension to farmers, families, and communities.

he 1890 land-grant universities and Tuskegee University (the 1890 Institutions) have an integrated mission to conduct research, educate undergraduate and graduate students, and provide public outreach (Extension). The 1890s Extension program, is comprised of a broad range of science-based educational efforts which have been proven to:

- Strengthen the agricultural industry (especially small farmers)
   by developing agricultural production systems that are efficient,
   sustainable, and highly competitive in the global economy.
- Enhance the health of families through diet/nutrition and food safety education and their economic well-being through practical financial education.
- Foster strong, stable communities through leadership development efforts and encouraging entrepreneurship.

Although these Extension programs serve a diverse clientele, emphasis is placed on those with limited social and economic resources.

The primary funding source for 1890s Extension is the National Institute of Food and Agriculture (NIFA), USDA's extramural science funding agency. NIFA funds are



matched with state monies and some institutions also receive limited support from county governments.

Congress recognized the enormous national value of the 1890s Extension program by providing modest increases in recent appropriations bills. A·P·L·U supports an FY 2012 funding level for this program that continues the modest growth trend from the last few years.
