# Highlights

- AEA summer meeting was held June 15-18, 2009 in Charleston, SC and South Carolina State served as the host institution
- The meeting focused on enhancing participation in Competitive Grant programs
- USDA Agency participating included RMA, RD, CSREES, and SARE Representative
- AEA program teams met with the Extension Administrators to begin drafting competitive proposals to submit for funding.
- Met jointly with ARD executive committee to discuss budget and legislative issues and to outline joint initiatives



# Highlights Cont.

- Participated in ECOP webinar to discuss the restructuring of the BAC and Farm Bill Committee
- Presented Report at the Council of 1890
  Presidents/ Chancellors Meeting in Nashville
- Dr. M. Ray McKinnie is the chair-elect of ECOP
- Dr. Gina E. Eubanks will be Extension's nominee for the BAA Policy Board of Directors



# Highlights Cont.

- Participated in 2009 Exhibition on Capitol Hill
- Continue to participate in the APLU Board on Agriculture Assembly BAC meetings and conference calls - Henry Brooks Represents Extension
- Need more congressional members completing the appropriate forms asking for 1890 funding
- 2010 budget markups were very favorable in the House and less favorable in the Senate for Extension

- House \$44.0 M Senate \$41.4 M

• Will advocate for higher number in conference



### Extension Activities and Initiatives Update



### Food, Conservation, and Energy Act 2008

- All 1890 programs were reauthorized with increases in authorization levels
- Represented on the Implementation Team
- Provided Stakeholder Comments
  - Children Youth and Family at Risk (CYFAR)
  - Integrated Pest Management (IPM) Program
  - National Institute of Food and Agriculture (NIFA)
  - 1890 Capacity Building Grants Program
  - Agriculture and Food Research Initiative (AFRI)



Expanded Food Nutrition Education (EFNEP)

- Prior to 2006, 1890s were not eligible participants
- 1890s received \$400,000 in 2006
- Language was sort and approved in the budget in 2007 to increase the funding to \$100K
- The Farm Bill authorized a minimum of \$100K per year to all 1862 and 1890 institutions and stipulated a 10-15% increase for 1890s for any appropriations above F.Y. 2007 level of (\$63.5M) (FY'2010 68M)
- All 1890s are presently receiving more than \$100K per year



#### **CYFAR**

- Competitive grant program
- First year for the 1890s to participate
- Focuses on outreach and after school programs, including STEM
- Eight proposals submitted from 1890 Universities in 2009
- Four proposals funded- A&T, FAMU, WV, Tusk



## Socially Disadvantaged Farmers and Ranchers Program - 2501

- Program focuses on outreach and technical assistance
- Competitive program for 1890s, 1862s, CBOs, 1994s, Hispanic Serving and others

# Rural Development Workshop

- Participated in the USDA Rural Development Agency, Information Exchange for 1890 Universities on July 7-8, 2009, in New Orleans
- Purpose:
  - To update the 1890s on rural business development programs within USDA
  - For 1890s to report progress of their Rural Business Initiatives
- Rural Development Agency has cooperative agreements with 15 1890 universities
- Allocated \$1.5M to support the agreements
- The focus is on rural business development
- Served on a panel to discuss strategies for enhancing the partnership between Rural Development and 1890 Extension



### Extension Disaster Education Network (EDEN)

- Focuses on delivering education programs and technical assistance before and after a disaster to assist families and communities
- Ensure that each 1890 institution is a member of EDEN
- Will conduct a workshop to orientate 1890 representatives on roles and responsibilities
- In process of acquiring grant for \$20,000 to support the workshop
- Delaware State University will be the host institution



## National Extension and Research Administrative Officers' Conference

- 1890s were represented at this USDA meeting in April 2009
- Focused on updating the system on rules and regulations pertaining to use and management of federal funds
- 1890s presented a session on acquiring and sustaining matching funds
- It was reported that there would probably be an increase in requests for waivers this year



#### Small Farmer Leadership Institute

- Hosted by Southern University Ag Center
- Funded by USDA 2501 Program
- Two-year program for minority and small farmers focusing on enhancing leadership and business management skills
- Second class graduated March 2009 and Secretary of Agriculture was the keynote speaker
- 30 participants representing 14 1890 universities
- Class graduates are assuming leadership role in the community on boards, councils, and USDA committees
- Currently recruiting for the third class that will begin October 2009



# **Other Areas of Importance**

- Department of Defense Partnerships addressing issues of military families
- Department of Energy- funding in Farm Bill
- Developing Champions to support federal budget initiatives
- Articulating our Value to stakeholders ensuring that decision makers and others know the value of our contributions and impact of our programs
