thank the ARD members, researchers, supporters, friends, the 1890 Universities Foundation and our executive director who have worked tirelessly to advance the ARD vision, mission, goals, values and value proposition.

At the APLU 2019 annual meeting last month in San Diego, ARD, AEA and the Council of 1890 Deans of Agriculture had a joint meeting with the Council of 1890 Presidents and Chancellors. Paul Brathwaite, Federal Street Strategies, gave the 1890 leadership an update on the legislative actions affecting the 1890 community, including, but not limited to, the Future Act, pending decisions about the 1890/USDA Task Force, 1890 Scholarship Program, 1890 Centers of Excellence, Carryover Disparity for 1890 Extension and leveraging visits by Secretary Perdue and other high-ranking officials of the Trump Administration. Brathwaite also encouraged the 1890 leaders to be more engaged with their state and federal elected officials.

A second purpose of the joint meeting was to vet the RFA for the 1890 Centers of Excellence that was released four days prior to the meeting. The RFA was straightforward; however, the time to prepare and submit the Letter of Intent (Dec.) and

the full proposal was short. The convening event held in Atlanta in Octo-


Neufville wins ESS Leadership Award

Dr. Mortimer H. Neufville received the ESS National Excellence in Leadership Award from the ARD region at the 2019 APLU Annual Meeting in San Diego, CA. Neufville currently serves as the president and CEO of The 1890 Universities Foundation, a 501 c (3) dedicated to facilitate partnerships, foster collaborations with USDA agencies and implement centers of excellence across the community of 1890 Universities.

Neufville is a collaborative leader with a demonstrated record of creating and implementing mission-aligned academic, research and Cooperative Extension programs. Neufville thoroughly understands

and appreciates the land-grant system as manifested most succinctly by his visionary and contemporary leadership over the past 40 years in several administrative roles in higher education and international development. Neufville has worked with intensity, passion and deliberate thought to create a strong food and agricultural system that motivates administrators, faculty and students.

Neufville has served in a number of critical leadership positions including president of Coppin State University, interim president of the University of Maryland Eastern Shore, executive vice president of the National Association of

State Universities and Land Grant Colleges (NASULGC), and vice president for academic affairs and dean and research director of the School of Agricultural and Natural Sciences at the University of Maryland Eastern Shore. In addition, Neufville has served as the associate dean of the College of Agriculture and Applied Sciences and Cooperative Extension and Research at Lincoln University, chair of the Association of Research Directors (ARD), chair of the Council of 1890 Deans of Agriculture and chair of the Board of the International Adult and Continuing Education.

In addition, Neufville currently serves as a consultant for ACDI/ VOCA, as a member of the Maryland Governor's Intergovernmental Commission on Agriculture and is a commissioner of the Food Systems Leadership Institute (FSLI).

Nominations open for ESCOP/ESS awards

EXCELLENCE IN LEADERSHIP

This award recognizes those who have served the Regional Associations, ESCOP—ESS and/or the national landgrant system with exemplary distinction.

ELIGIBILITY

Individuals eligible for this award are former or current State Agricultural Experiment/Research Station (SAES or ARD) leaders who have provided service as assistant director, associate director, director, administrator or as chief operating officers with equivalent, but variant titles (e.g. vice chancellor, associate vice chancellor, associate vice president, dean for research) and/or as a regional executive director.

This award is distinctive in its expectations and <u>not</u> necessarily coincident with retirement, election to a specific office or any other specific professional benchmark.

SUBMISSION AND REVIEW

Nominations for the recognition in the 1890 region should be submitted to Dr. Alton Thompson by Feb. 1, 2020. The ARD Executive Committee will review the nominations and email to the ARD members in good standing to select the winner. The nominee with the most votes will be submitted to the ESS chair and the executive vice-chair and the executive vice-chair of the Science the Technology Committee. EXCELLENCE IN MULTISTATE RESEARCH

The purpose of this award program is to annually recognize those station scientists who are conducting exem-

plary multistate activities and enhance the visibility of the multistate program. A recipient multistate project will be selected from the pool of nominees submitted by the five regional research associations and judged by the ESCOP Science and Technology Committee to exhibit sustained, meritorious and exceptional multistate research activities. The ES-

COP Executive Committee will provide final approval.

ELIGIBILITY

Any current multistate project (research, ERA, CC) listed in NIMSS (www.nimss.org) is eligible for consideration. The nomination is predominantly based upon the five-year project period. The multistate research authority allows

other non-SAES partners to join in these project-based collaborations. Thus, many multistate projects include Extension specialists and ARS or Forest Service research scientists. Many projects have private sector and non-land-grant participants and a majority of multistate projects have participants from more than a single region.

BASIS FOR NOMINATION

Each of the five regions may nominate one multistate project. An individual project should document collaborative activities. Nominations shall be made to the chair of the respective regional Multistate Research Committee (MRC) or Multistate Activities Committee (MAC) via the regional executive director's office. Nominations are due in the Office in the Executive Directors on or before Feb. 28, 2020. Click here to view the call for nominations.
