FAMU granted two new patents for muscadine grape plants

Florida A&M University has been granted two new grape patents:

Muscadine grape plant named 'Floriana'

U.S. Patent, PP31,654 – red wine muscadine cultivar; April 14; Ren, Z., Lu., J., and V. Tsolova

'Floriana' is a new muscadine cultivar bred for red wine grape industries in Florida and the southeastern U.S., at the Center for Viticulture & Small Fruit Research, the College of Agriculture and Food Science (CAFS), Florida **A&M** University



(FAMU). 'Floriana' is a self-fertile wine grape vine that is highly productive, resistant to Pierce's disease (PD) and low -fruit ripening rot (ripe rot, and bitter rot), and is able to produce fine red wines. The most outstanding characteristics of 'Floriana' are a high-quality wine with rich and stable red color and consistent high yield.

Muscadine grape plant named `Florida Onyx`

U.S. Patent, PP31,407 - large berry red fresh fruit muscadine cultivar; Jan. 18; Ren, Z., Lu., J., and V. Tsolova

'Florida Onyx' is a new muscadine cultivar bred for the fresh fruit grape industry in Florida and the southeastern U.S. at the Center for Viticulture & Small Fruit Research, at CAFS at FAMU. 'Onyx' is a pistillate (female) grape vine that is highly productive, resistant to Pierce's disease (PD), low-fruit ripening rot (ripe rot, and bitter rot) and relatively low wet scar. The most outstanding characteristics of 'Florida Onyx' are a very large deep black-red colored berry with an extremely pleasant fruit flavor.

As we look ahead, ARD and the other four ESCOP regional research associations are committed to a long-term diversity and inclusion agenda for the Experiment Station Section (ESS) with goals, metrics, timelines, implementation activities and continuity of practice. As a standing committee of ESS, the Diversity Catalyst Committee (DCC) engages in topics of diversity in research leadership across the land-grant university system, provides ideas and actions for consideration and supplements institutional, regional and national diversity and inclusion efforts. Ali Fares, Prairie View A&M University, chairs this important committee and is supported by Richard Rhodes, executive director for the Northeastern Regional Association of State Agricultural Experiment Station Directors (NERA). ARD, as part of ESCOP, will continue to support and amplify the work of the DCC to build a more diverse and inclusive research enterprise in the land-grant system.

As we continue to adjust to this "new normal," I sincerely thank you for participating in and being fully engaged in ARD's virtual summer business meeting held jointly with AEA.

Although our agenda was quite ambitious, let me focus briefly on two important programs authorized by the 2018 Farm Bill – the Centers of Excellence and the Scholarships for Students at 1890 Institutions.

Briefly, the 2018 Farm Bill authorized the Secretary of Agriculture to recognize not less than three centers of excel-

lence, each led by an 1890 institution. AEA, ARD and the Council of 1890 Deans of Agriculture supported the implementation

of all six centers identified in the 2018 Farm Bill. However, because the FY 2019 Agriculture Appropriations Bill preceded that of the 2018 Farm Bill, the USDA General Counsel informed the 1890 community that the \$5 million allocation can only be used for the legislatively authorized centers at the time when the Appropriations Bill was passed (i.e., the three centers of excellence that were authorized in 2015). The three centers are (1) Virtual Center to Motivate and Educate for Achievement (MEA); (2) Center for International Engagement and Development (CEIED) and (3) Center for Innovative and Sustainable Small Farms, Ranches and Landowners (CISFRL).

Using a competitive process developed by NIFA, North Carolina A&T State University was selected to host the MEA Center; the University of Maryland Eastern Shore was selected to host the CEIED and Tuskegee University was selected to host the CISFRL. The intent of the 1890 COEs is to increase profitability and rural prosperity in underserved farming communities; address critical needs for enhanced international training and development; and increase diversity in the science, technology, engineering, agriculture and mathematics (STEAM) pipeline.

The anticipated amount available for grants in FY 2020 is approximately \$4.8 million. The center directors, coinvestigators and staff are working seamlessly with the 1890

Universities Foundation, an executive committee comprising representatives of participating 1890 universities and a governing board with representation from each of the 19 universities. External technical advisory boards will also support these centers

As envisioned, these centers will create a dynamic, collaborative partnership of the 1890 institutions and USDA. The partnership will leverage the collective capacity of the partner institutions and their domestic and international partners to develop and deliver interdisciplinary, multistate and integrated research, education and engagement initiatives to help address critical challenges in the food system.

The 1890 COEs will solicit proposals from the 1890 institutions through a fair and transparent competitive process. All projects funded by the centers must address the identified objectives and priorities. The solicitations will encourage multidisciplinary and multi-institutional projects. Presently, RFAs have been developed in selected topics related to the thematic/thrust areas of each center. This will allow for broad-based competitive participation by all of the 1890 universities to collectively achieve each center's mission.

As championed by U.S. Rep. David Scott (D-GA) and authorized in the 2018 Farm Bill passed by Congress in December 2018, funds for the Scholarships for Students at 1890 Institutions have been released to all of the 1890 institutions. As authorized, the purpose of this significant scholarship program is to "provide scholarships to support recruiting, engaging, retain-

ing, mentoring and training of undergraduate students at the 1890 land-grant institutions, resulting in baccalaureate degrees in the food and agricultural sciences and re-

lated fields." The scholarships are intended to encourage outstanding students at 1890 institutions to pursue and complete baccalaureate degrees in the food and agricultural sciences and related fields that would lead to a highly skilled food and agricultural systems workforce. As such, the Council of 1890 Deans of Agriculture has appointed project directors to individually and collectively implement this significant investment in the 1890 system. The project directors are meeting virtually on a regular basis to discuss scholarship management and implementation, recruitment and retention strategies, methods of awarding scholarships, promising and best practices, value-added professional development; documentation, evaluation and reporting metrics and engaging students during the summer.

Finally, as the summer season is upon us, let me encourage you to spend some quality time with your families. Our ARD family is strong and vibrant because you have a sound foundation at home. A strong foundation at home requires an investment of 'time.' Take advantage of being 'sheltered-in' to enjoy your family time while concurrently working diligently to fulfil your duties and responsibilities as research directors and deans.
