IMPORTANT FARM BILL GUIDANCE: The implications of the expiration of the 2008 Farm Bill

Many programs and policies of the U.S. Department of Agriculture (USDA) were authorized under the Food, Conservation and Energy Act of 2008 ("2008 Farm Bill") through September 30, 2012. Beginning October 1, 2012 the authority or funding provided under the 2008 Farm Bill for USDA to operate a number of these programs expired, including the following NIFA programs: Organic Agriculture Research and Extension Initiative, the Specialty Crop Research Initiative, the Beginning Farmers and Ranchers Development Program, the Biomass Research and Development Initiative, and the Biodiesel Fuel Education Program. Until now, Congress has still not passed a 2012 Food, Farm and Jobs Act or other legislation extending the authority for USDA to carry out this program, and USDA cannot make new commitments to these programs. Because the authority for these programs has expired, NIFA cannot move forward on the release of new RFAs for these programs. NIFA can continue to manage existing grant awards that were made in FY 2012 and previous years. Note that two of the mandatory-funded programs, Community Food Projects and Risk Management Education, receive funding that is subject to the OMB operating guidance and legislative provisions of the FY 2013 Continuing Resolution. Therefore, these programs are not impacted by the expiration of the Farm Bill.

The AFRI Foundational Program is offered to support research grants in the six AFRI priority areas to continue building a foundation of knowledge critical for solving current and future societal challenges. The six priority areas are: Plant Health and Production and Plant Products; Animal Health and Production and Animal Products; Food Safety, Nutrition, and Health; Renewable Energy, Natural Resources, and Environment; Agriculture Systems and Technology; and Agriculture Economics and Rural Communities. Single-function Research Projects, multi-function Integrated Projects and Food and Agricultural Science Enhancement (FASE) Grants are expected to address one of the Program Area Priorities (see Foundational Program RFA for details).

1890s Receiving McIntire-Stennis Funding Are All Members of the National Association of University Forest Resources Programs (NAUFRP)

The NAUFRP Executive Committee and subsequently the NAUFRP general assembly voted unanimously to accept a change in its Bylaws to include the 1890 Universities as members and that they shall be represented on the Executive Committee by the ARD Executive Director as one of the voting members. Thus all of the thirteen 1890 McIntire-Stennis campuses



shall receive equal benefits, voting privileges and the opportunity to be appointed to committees and serve as officers of NAUFRP. The combined dues for the 1890 institution members of NAUFRP will be paid by the ARD.
