Dear Colleagues:

I was pleased to represent both Delaware State University and the Association of 1890 Research Directors when I visited both the Delaware Senator, Senator Tom Carper and Secretary of Agriculture Tom Vilsak at the Delaware Agriculture Industries annual dinner. When talking to Secretary Vilsak I thanked him for the support he has provided the 1890 Universities during his tenure, but also described our initiatives to establish one or two 1890 consortia related to national priorities to both Sec. Vilsak and Senator Carper. I indicated that we hope agencies within the USDA will provide financial sup-

port for our collaborative efforts and the Secretary is open to discussing this further.

During the opening ceremony of the fair, and before numerous dignitaries and distinguished guests, Fort Valley State University was singled out for deep appreciation for providing one of the St. Croix high school students with a scholarship. It is hoped that the 1890 universities will

consider developing an MOU with UVI St. Croix to offer at least one scholarship each to promising Virgin Island High School students (as they are U.S. citizens.)
