This will be the largest symposium ever. More than 600 oral and poster presentations will be made compared to 523 in 2011. Accordingly, student posters will be showcased Sunday-Monday and faculty posters will be showcased Monday through Tuesday. Campuses should make room reservations at the Hyatt Regency Jacksonville Riverfront, however Hyatt rooms for Saturday, April 6th are in very limited supply, even though rooms are still available on other nights. Homeland Security

The U.S. Department of Homeland Security (DHS) is offering faculty and students at Minority Serving Institutions an opportunity to participate in a ten-week summer research team experience at university-based DHS Centers of Excellence. At the end of the summer, faculty participants are encouraged to apply for up to \$50,000 in follow-on funding to continue the research collaboration at their home academic institutions during the following academic year. Faculty from all science, technology, engineering and math (STEM) disciplines are encouraged to apply, including faculty in agricultural sciences, biological/life sciences, computer and information sciences, engineering, mathematics, physical sciences, psychology, and social sciences. Dr. Gilbert Rochon, President of Tuskegee University announced the appointment of Walter A. Hill as vice provost and dean of the College of Agriculture, Environment and Nutrition Sciences, effective December 1, 2012. "Dean Hill has shown remarkable leadership at Tuskegee University, at the regional level with his engagement with the Alabama Agricultural and Land Grant Alliance, the Professional Agricultural Workers Conference, and nationally with the 1890 Council of Deans," Rochon said.

Hill received his doctorate in agronomy and environmental chemistry from the University of Illinois, master's degrees from both the University of Arizona and the University of Chicago and his undergraduate degree from Lake Forest College in Illinois. Hill currently serves as director of the George Washington Carver Agricultural Experiment Station and the 1890 Research and Extension Programs at Tuskegee.

Senate Passes One Year Farm Bill Extension

Unfortunately four National Institute of Food and Agriculture (NIFA) programs with mandatory funding (not subject to annual appropriations) in FY 2012, would not receive such funding in the current fiscal year (FY 2013). These four programs are Organic Ag Research & Extension Initiative, Specialty Crops Research Initiative, Beginning Farmer & Rancher Development, and Biomass Research & Development (R&D). The next action is that the House will take on this Senate action. The House has essentially three choices: reject the bill, pass it as adopted by the Senate, or amend the bill and quickly return it to the Senate. As the New York Times accurately states: "Any failure to pass the measure before the 112th Congress ends would require the process to start over in the new 113th Congress, meaning the Senate would have to vote again with a changed membership due to the departure of several veteran lawmakers and the arrival of newcomers from both parties as a result of victories in the November elections."

AFRI NIFA Fellowships Program

The FY 2013 AFRI NIFA Fellowships Program RFA has recently been posted on the NIFA website. This program invites proposals from individual graduate students for two years of pre-doctoral studies and post-doctoral researchers for 2 year appointments. Applicants must be the student/post-doc themselves; mentors or faculty are not eligible to apply. Applicants must secure the support of at least one mentor and must meet additional eligibility requirements, including limits on time until/since obtaining doctoral degree. All applicants must be Citizens, National, or Permanent Residents of the United States. Proposed projects must address at least one of the Agriculture and Food Research Initiative's (AFRI) six foundational areas or five challenge areas.

Letters of Intent are REQUIRED for this program (see RFA for specific formatting and content requirements) and are due January 3rd, 2013 by email to NIFAFellows@nifa.usda.gov. Full applications from those with accepted Letters of Intent are due March 7th, 2013 via Grants.gov.
