# Motion On the Timely Hiring of Adjuncts

UMES Faculty Assembly requests that the UMES Office of Academic Affairs take whatever action is necessary to insure that, starting with courses for the Spring Semester 2012, UMES is in compliance with the "45-day" rule on contracts for adjunct faculty. While we understand that there can always be special circumstances resulting in the late awarding of such contracts, we support the view of the Board of Regents that any

unnecessarily delayed adjunct contracts are both unfair to the adjuncts involved and to the students they are assigned to teach.

# Motion on Automatic Feedback to Advisors

The UMES Faculty Assembly requests that the UMES Office of Academic Affairs take the necessary steps to determine the feasibility to assure the early implementation of modifications to the current student registration system so that both, as students originally enter their courses into the system and, at every occasion later when they enter changes into the system, the system will automatically send e-mail to the students' advisors informing them on the selections and changes made. Currently, there are too many students attending advising sessions with their advisors, agreeing to one set of courses who then go and either register for a different set of courses (or register for the original courses in case the advisor has relatively few advisees and might be checking and then several days or a week later, change the courses to something the student prefers). Such unapproved changes can lead to delays in student graduation when students have not taken the required courses, to students completing courses that they do not need, and to students not passing courses for which they were not yet prepared. Having an automatic feedback to the advisor will help assure that early intervention is possible and still not put any long-term additional burden on those working on the registration process in the Registrar's Office or in Academic Computing.

A. Revised Alternative Credits Policy:

Mark Williams moved to accept; seconded. Motion passes to change alternative credit proposed policy with modifications. This will go to the senate for a vote.

# CURRENT POLICY WITH PROPOSED CHANGE NOTED IN BOLD-FACE

## **Alternative Credits**

All students who enroll in degree programs will be required to complete 12 alternative credits before graduating. Alternative credits can be earned by completing internships, summer and winter session

courses, on-line courses, **independent study**, **credit by examination** and courses completed while studying abroad.

- B. Need to amend motions:
  - Derry Stufft made motion to amend and it was seconded: should say "All undergraduate students" instead of "all students" Voted and passed
  - ii. Linda Johnson Moved to include "undergraduate research"; Seconded Discussion. The sentence should read: "independent study, undergraduate research"

Voted and passed.

Discussion: credit by exam-should be included or not? Credit is given to UMES students for prior knowledge. This does have the property of not taking classroom space, does give UMES credit.

iii. Emmanuel Onyeozili made motion made to eliminate "Credit by exam" seconded. Discussion. Transfer credit does not qualify since it is not "UMES generated.

Vote to remove "credit by exam" Modification to remove failed.

b. Adjunct Faculty Evaluation Form – PROPOSAL BELOW Discussion about the standardization of evaluation for adjunct faculty- this does correspond with intent of regents. Call for a motion: Moved and seconded. Vote: Passed Topics on problems for adjuncts will be at another meeting.

A. Chapin-Williams letter on our Tenure and Promotion document

Still no resolution on this – 1989 document is still in effect. Need approval from across the Bay.

B. CUSF report -- meeting occurs this Friday
Distance Education: Expertise is at University
College. Federal requirements going through courts- must satisfy all requirements for other states, and must pay for implementing course in each state.

Working on Common Core Goals as it is required for "Moving up to the top". Secondary school officials have the authority to determine the tests.

When the legislature looked, historically black universities are using more and more adjuncts, and graduation rates are lower. A report by the schools involved has been mandated.
