Instructions for Reference List:

- Formatting: All entries are double spaced with a hanging indent starting at the second line.
- Entries are listed in alphabetical order by author's last name or by the title of the source.
- The author's first and middle name should be written as initials.
- For entries with two authors, use a comma and ampersand (&) before the second author's last name.
- Titles: For books, websites and article titles capitalize *only* the first word in the title and subtitle – and proper nouns. For **academic journal titles** and **newspapers**, capitalize each major word in the title.
